- Booth space is approximately 15' x 15' and is located atop asphalt. Vendors may purchase multiple booths.
- Limited grassy areas are available, must be requested in advance, and will be accommodated as the design of the festival allows; grassy areas are not guaranteed.
- Vendors must provide their own booth tents/canopies, displays, tables, and chairs. Tents must be weighted; no stakes are allowed into the asphalt.
- Limited electrical power is available to vendors. An additional \$25 fee will be charged.
- Vendor spaces will be assigned by the festival staff.
- Markets may not contain catalogue/order services.
