The Penny McHenry Hydrangea Festival is a nationally recognized and award-winning Festival bringing thousands of festival-goers to share in their love and appreciation of the flowering plant and artisans' crafts.

Please read over the entire application and information before filling out your application, as there have been changes from previous years. Also, please note that upon submitting your application you must pay the Space Rental Fee(s). Electricity is an additional charge.

The Penny McHenry Hydrangea Festival reserves the right to make final interpretation of all rules. An application is a commitment to show. NO REFUNDS WILL BE MADE FOR CANCELLATION OR REMOVAL FOR CAUSE. In an event of unforeseen circumstances, the show may be terminated at our discretion. NO REFUNDS WILL BE MADE FOR BAD WEATHER – THIS EVENT IS RAIN OR SHINE.

PRODUCT & EXHIBIT

1. Items not created by the exhibitor or not in the category for which applied will not be permitted in the show.
2. Resale of wholesale items (buy/sell), commercially manufactured products, mass produced items and kits ARE NOT PERMITTED and will result in immediate dismissal without refund.
3. Exhibitors may only show and sell work from the category in which they have been accepted.
4. Any items of work not created by the exhibitor must be removed from the show.

BOOTH DISPLAY & SET-UP

1. Booth space is limited to the size in which you paid. Single spaces are 10' wide x 10' deep. Double spaces are 20' wide x 20' deep.
2. Booths must be neat in appearance and not distract from neighboring displays. Each space must be left clean at the end of the day.
3. All exhibitors will be required to supply their own tents, tables, chairs, electrical cords, etc.
4. Electricity is a PAID amenity. You must pay when you apply. Electricity is limited and cannot be guaranteed.
5. Exhibitors are not allowed to stake tents into the asphalt or concrete on the show grounds. **Bring weights to secure your tent. A portion of the booths are located on asphalt.**
6. All displays, transactions and activities must be confined to exhibitor's assigned space. Signs, tents, canopies, or other parts or displays may not extend over into walkways.
7. Exhibitors are required to handle their own Sales Tax.

FESTIVAL RULES

1. The Penny McHenry Hydrangea Festival is not responsible for damage to personal property or stolen property during the event or overnight. Overnight security is provided on Friday and Saturday starting at 5 PM.
8. Booths **cannot** open late or close early at any time – you **must** be on time and stay for the duration of the Festival. Failure to comply will forfeit participation in future events.
2. Prior to the Festival, Exhibitors will be notified of their site location and detailed setup information. Setup for the Festival is Friday, May 31, 2019 from 12 pm – 5 pm.

3. After unloading, Exhibitor vehicles must be moved to the designated parking area. Vehicles will not be permitted to remain in the Exhibition space during the Festival, nor may they enter the Festival grounds until approved by the Festival Committee.
4. The Festival is a rain or shine event.

CRAFTER CHECK-IN

1. Exhibitor must check-in in person and attend the show in its entirety.
2. Exhibitor **MUST** check-in during official check-in times. Exhibitors not checked-in by the deadline will forfeit their exhibition space and all fees.

EXHIBITOR INFORMATION

Arts & Crafts Exhibitors: All artwork must be original art and/or handmade by the artist or crafter. All artist and crafter applications will be juried. Acceptance is not guaranteed to anyone. **Each applicant must submit 8 color pictures with each application.** Jury decisions are based on your photos and information provided with your application. Decisions will be made upon application and payment submission. Please send the best photos you have available. Your photos are the most important factor in your acceptance/non-acceptance to the festival. Exhibitor selections are based on quality and skill in workmanship, original and creative ideas as well as attractiveness of booth display. If you are not selected, you will be reimbursed your booth fee.

Non-Profit Organizations: Groups may display literature/projects that the group undertakes and supports. Non-Profit groups wishing to sell items must **NOT** sell items that compete with any hand-made item sold by an artist or crafter. Exhibitors must provide non-profit documentation with the application. Non-Profit applications will be juried upon application and payment submission. If not accepted, you will be reimbursed your booth fee.
